Release, Indemnification and Hold Harmless Agreement

In consideration of participating in CORE Community Center activities, and for other good and valuable consideration, I hereby agreed to release and discharge from liability arising from negligence CORE Community Center and its owners, directors, officers, employees, agents, volunteers, participants, and all other persons or entities acting for them Of participating in CORE Community Center activities, and for other good and valuable consideration, I hear by agreed to release and discharge from liability arising from negligence CORE Community Center and its owners, directors, officers, employees, agents, volunteers, participants, and all other persons or entities acting for them(hereinafter Collectively referred to as "releasees"), on behalf of myself and my children, parents common errors, assigns, personal representative and estate, and also agree as follows:

1. I acknowledge that participating in CORE Community Center activities involves known and unanticipated risks which could result in physical or emotional injury, paralysis, or permanent disability, death, and property damage. Risks include, but are not limited to, broken bones, torn ligaments, or other injuries as a result of falls or contact with other participants; death as a result of drowning or brain damage caused by near drowning in pools or other bodies of water; medical conditions resulting from physical activity; and damaged clothing or of other property. I understand such a risk simply cannot be eliminated, despite the use of safety equipment, without jeopardizing the essential qualities of the activity.
2. I expressly accept and assume all of the risks inherent in this activity or that might have been caused by the negligence of the releasees. My participation in this activity is purely voluntary and i.e. like to participate despite the risks. In addition, if at any time I believe that event conditions are unsafe or that I am unable to participate due to a physical or medical condition, then I will immediately discontinue participation
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless releases from any and all claims, demands, or causes of action which are in any way connected with my release does not apply to claims arising from intentional conduct. Should releasees or anyone acting on their behalf be required to incur attorneys fees and costs to enforce this agreement I agree to indemnify and hold them harmless for all such fees and costs.
4. I represent that I have adequate insurance to cover any injury or damage I may suffer or cause while participating in this activity, or else I agree to bear the cost of such injury or damage myself. I further say I have no medical or physical condition which could interfere with my safety in this activity, or else I am willing to assume and bear the cost of I'll risk that may be creative, directly or indirectly, by any such condition.
5. In the event that I file a lawsuit, I agreed to do so in the state where the releasees facility is located, and I further agree with the substantive law of that state.

By signing this document, I agree that if I am hurt or my property is damaged during my participation in this activity, that I may be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of negligence.
